<p><b>General:</b>                      We are of the view that all of the proposed amendments to the Principal Deed as set out in the Eleventh Supplemental Deed (“<b>Proposed Amendments</b>”) will not materially prejudice the unit holders’ interests as there is no:</p> <ol style="list-style-type: none"> <li>1. change to the nature or objective of the Fund;</li> <li>2. change to the risk profile of the Fund;</li> <li>3. change in the distribution policy of the Fund;</li> <li>4. introduction of a new category of fees or charges; or</li> <li>5. increase in fees or charges of the Fund,</li> </ol> <p>(“<b>Material Prejudice Circumstances</b>”)</p> <p>as a result of the Proposed Amendments.</p> <p>The Proposed Amendments essentially entail the amendments to the provisions of the Principal Deed to be in line with the Guidelines on Unit Trust Funds (Revised: 21 December 2021) (“<b>Revised GUTF</b>”). As such, the Proposed Amendments do not materially prejudice the unit holders’ interests under paragraph 9.70 of the Revised GUTF and hence a unit holders’ approval is not required under section 295(4)(a) of the Capital Markets and Services Act 2007 (“<b>CMSA</b>”).</p> <p>In addition, we are of the view that the Proposed Amendments are not significant changes that will affect unit holders’ decision to stay invested in the Fund as there is no change in investment strategy, distribution policy or minimum balance of the Fund (“<b>Significant Change Circumstances</b>”).</p> <p>We will issue a written notice to unit holders of the Proposed Amendments not less than 14 days before the date of the replacement prospectus of the Fund.</p>

Appointment of Investment Committee**
